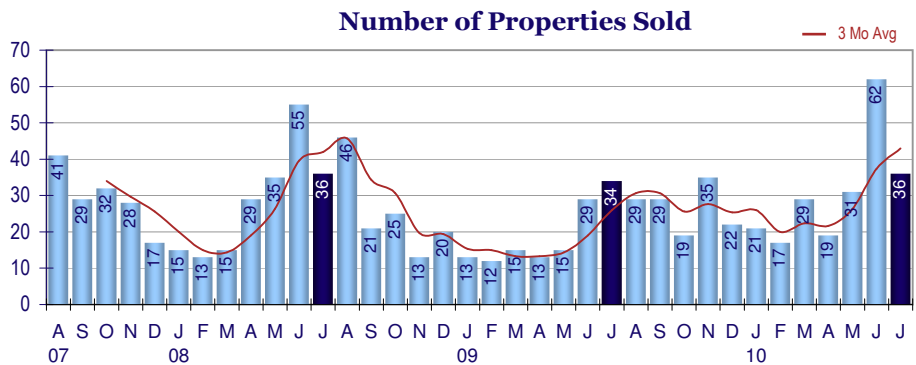

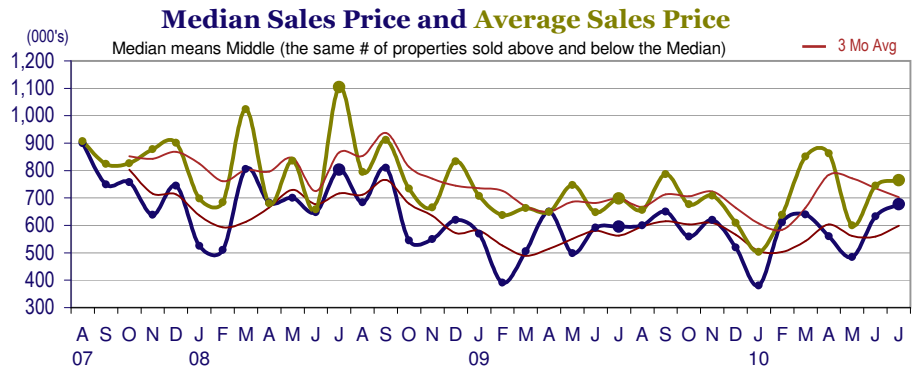
Property Sales

July Property sales were 36, up 5.9% from 34 in July of 2009 and -41.9% lower than the 62 sales last month. July 2010 sales were at their highest level compared to July of 2009 and 2008. July YTD sales of 215 are running 64.1% ahead of last year's year-to-date sales of 131.



Prices

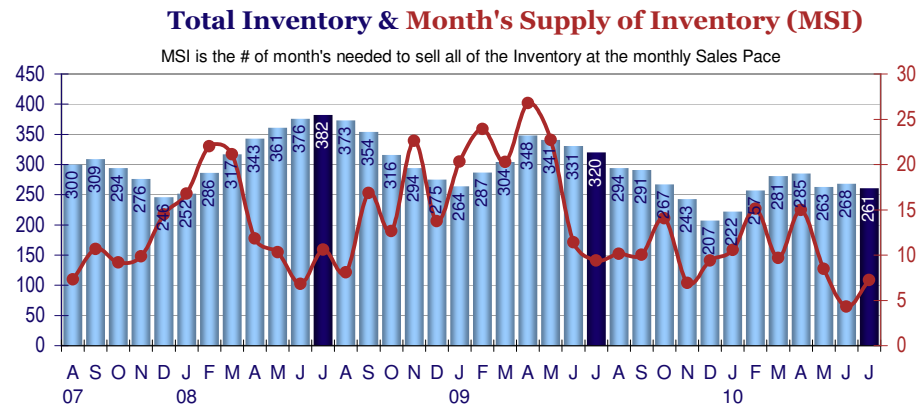
The Median Sales Price in July was \$677,000, up 13.7% from \$595,500 in July of 2009 and up 6.9% from \$633,250 last month. The Average Sales Price in July was \$764,794, up 9.5% from \$698,178 in July of 2009 and up 2.8% from \$744,169 last month. July 2010 ASP was at a mid range compared to July of 2009 and 2008.



Inventory & MSI

The Total Inventory of Properties available for sale as of July was 261, down -2.6% from 268 last month and down -18.4% from 320 in July of last year. July 2010 Inventory was at its lowest level compared with July of 2009 and 2008.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The July 2010 MSI of 7.3 months was at its lowest level compared with July of 2009 and 2008.

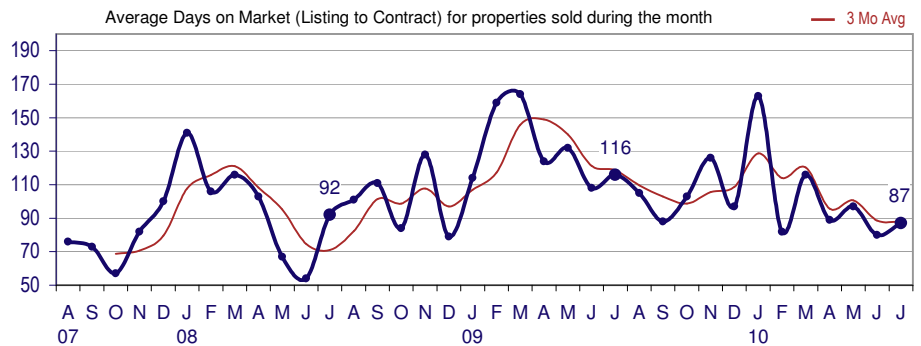

Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for July was 87, up 8.7% from 80 days last month and down -25.0% from 116 days in July of last year. The July 2010 DOM was at its lowest level compared with July of 2009 and 2008.

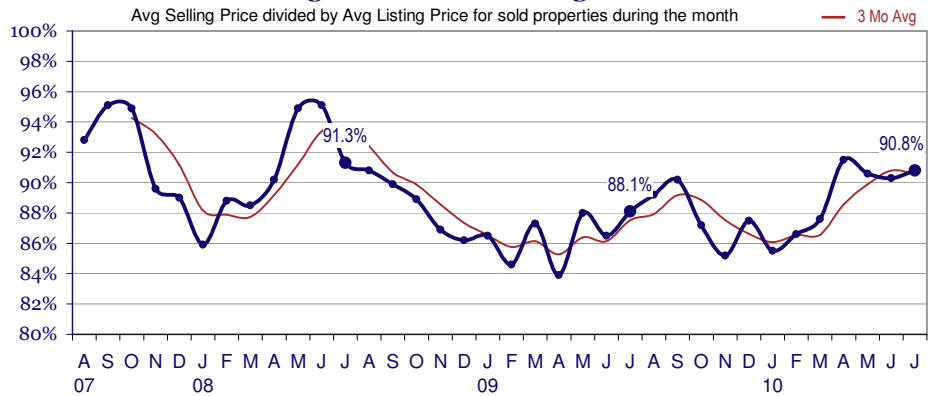
Days On Market for Sold Properties



Selling Price vs Original Listing Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The July 2010 Selling Price vs Original List Price of 90.8% was up from 90.3% last month and up from 88.1% in July of last year.

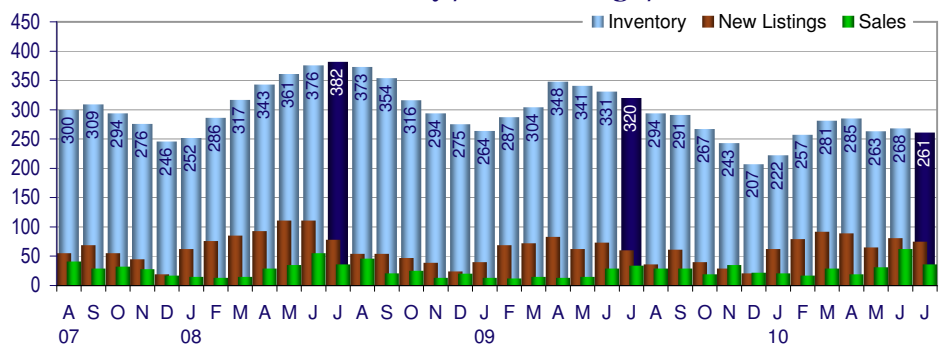
Selling Price versus Listing Price Ratio

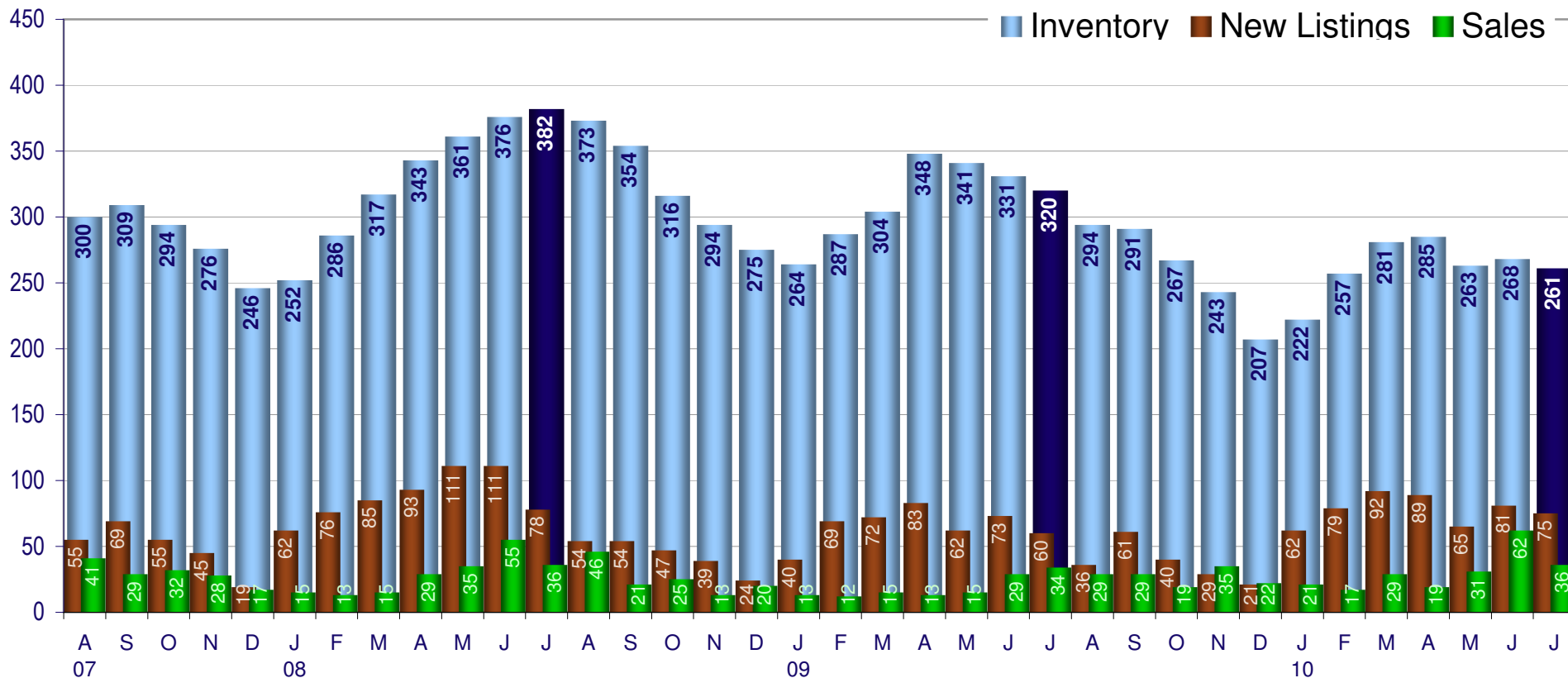
